CAN I TRAVEL ACROSS ITALY?

Any travel across the country is strictly forbidden.

EXCEPTIONS

TRAVELS ARE ONLY ALLOWED WITH A SELF-DECLARATION CERTIFYING

- an urgent, proven work-related reason;
- situations of special need;
- health reasons.

EACH SELF-DECLARATION WILL BE THOROUGHLY VERIFIED

CAN I LEAVE MY HOUSE?

Bans and recommendations also apply to all movements in your own town

EXCEPTIONS

MOVEMENTS ARE ONLY ALLOWED WITH A SELF-DECLARATION CERTIFYING

- an urgent, proven work-related reason;
- situations of special need;
- health reasons.

EACH SELF-DECLARATION WILL BE THOROUGHLY VERIFIED

CAN I GO TO WORK?

Only if you can prove that it is strictly necessary

DOCUMENTATION TO BE EXHIBITED TO LAW ENFORCEMENT OFFICERS

- Self-declaration
- Employer's declaration

EACH SELF-DECLARATION WILL BE THOROUGHLY VERIFIED

CAN I GO OUT IN SITUATIONS OF SPECIAL NEED?

Only if you can prove that it is strictly necessary and they cannot be delayed

FOR EXAMPLE

- if you need to buy food (as close to home as possible);
- avoid non-essential purchases;
- for urgent family matters (ill relatives);
- for the daily needs of your pets (walking your dog or taking it to the vet);

CAN I GO OUT FOR HEALTH REASONS?

Only if they are urgent and verifiable

DOCUMENTATION TO BE EXHIBITED TO LAW ENFORCEMENT OFFICERS

- Self-declaration
- Doctor's certificate

HAVE YOU BEEN QUARANTINED OR HAVE YOU TESTED POSITIVE FOR THE VIRUS?

Leaving your home is strictly forbidden.

IF YOU FAIL TO OBSERVE THIS RULE, YOU MAY FACE

Art. 650 c.c. Custody up to 3 months and a fine up to €206

Art. 452 c.c. 1 to 12 years in prison

HOW AM I SUPPOSED TO BEHAVE WHEN I'M OUTDOORS?

Avoid gatherings and keep a distance of at least 1 mt from other people

HOW WILL THE RESTRICTIONS ON PEOPLE'S MOVEMENTS BE ENFORCED?

Police checkpoints have been established and checks will be carried out by law enforcement operators

ARE YOU OLD OR CHRONICALLY ILL?

Don't leave your home, unless it is strictly necessary. Avoid crowded places and keep a distance of at least 1 mt from other people.

HAVE YOU GOT FEVER ABOVE 37.5 DEGREES AND/OR BREATHING DIFFICULTY?

Stay at home. Call your GP or pediatrician.

WHAT CAN I DO TO HELP?

Follow and share the advice provided by official sources. But above all, stay at home.

Only with public spirit shall we be able to overcome this moment and protect our health and that of elderly and seriously ill people.
